- Need to investigate options for the container -
 - Do we treat, have wooden floor repaired?
 - If repaired, what do we do with the container, as leaving it at current site (Chambers Flat) Is no longer feasible. Move to Bridge Club for additional storage or sell?
 - o If not repaired, do we sell as is (after termite treatment)

- Look into can we have it moved to the bridge club, Georgi to ask the Bridge Club if this an option. Georgi to also get pricing on termite treatment.
